I am writing to express my support for the FIX I-44 Multimodal Discretionary Grant. This project is essential to providing continued freight movement in Missouri. According to the Missouri Freight Plan, by 2045 the state transportation system is projected to have a 19% increase in freight tonnage and a 57% increase in freight value. Missouri is a distribution hub for the nation with over 300 trucking companies in the state, and Missouri continues to attract new businesses due to our business friendly climate and central location.

The I-44 corridor is a part of the National Highway Freight Network beginning in Wichita Falls and ending in St. Louis.
