Can only apply for an Action Plan Grant or an Implementation Grant - not both

- An Eligible Applicant can only submit one application
- Action Plan funding recipients are not excluded from applying for implementation in future rounds

# About Implementation Grants

- Fund projects and strategies identified in an Action Plan that addresses roadway safety problems
- Fund associated planning and design and supplemental Action Plan activities supporting existing plan
- Encouraged to include supplemental activities

# Successful Applications

- Promote safety
- Low-cost, high-impact strategies that improve safety over a wider geographic area
- Ensure equitable investment in the safety needs of underserved communities
- Incorporate evidence-based projects and strategies
- Align with the Department's mission/priorities such as equity, climate and sustainability, quality job creation, and economic strength and global competitiveness

# Funding

\$5 billion in advanced appropriations, including \$1 billion for FY 2022
 Funds must be expended within 5 years of executed agreement/obligation
 DOT expects to award 100s of Action Plan grants and up to 100 Implementation Grants
 80 percent federal share with non-federally sourced matching funds
 Joint applications are encouraged

## Timeline

Applications Due September 15, 2022

Agreement signed within 12 months of award announcement

Action Plans complete within 12 to 24 months of agreement

Implementation Projects may not exceed 5 years

- Combination of the above (with a lead applicant)
